REEA DREI Renewal Status Criteria

Please check the appropriate box below

A. Active Status: The REEA DREI is awarded for a one-year period. During the third year of original award, and subsequent (3) three-year renewal cycles, REEA DREI's must renew their REEA DREI. Successful exam performance and instructor video submission are not required for renewal.

Active renewal requirements are:

1. Pay annual \$75 renewal fee;
2. Maintain active REEA membership in good standing;
3. Submit an executed Renewal Affidavit attesting to active involvement in real estate education as a profession at time of renewal; and
4. Attend at least one (1) REEA DREI Summit in the previous three-year period.

B. Inactive Status: Inactive status is available to a REEA DREI after one (1) Active 3-year award period if designee cannot meet the criteria for a second (or subsequent) renewal term but wishes to retain the REEA DREI designation. REEA DREI's who are not currently involved in real estate education or have not met the REEA DREI Summit attendance requirement for active renewal would fall into this category. Inactive renewal requirements are:

1. Pay annual \$75 renewal fee;
2. Designees in this category must only refer to themselves as "REEA DREI (Inactive)";
3. Maintain active REEA membership in good standing; and
4. To reinstate Active Status, designees must meet the current Active REEA DREI renewal requirements.

C. Retired Status: REEA DREI's who are no longer actively involved in real estate education and have no future plans to become re-involved may select this category. Such REEA DREI's will neither be required to pay any annual fee/ REEA DREI dues nor to attend a REEA DREI Summit to maintain this status. Such REEA DREI's must only refer to themselves as "REEA DREI (Retired)".
